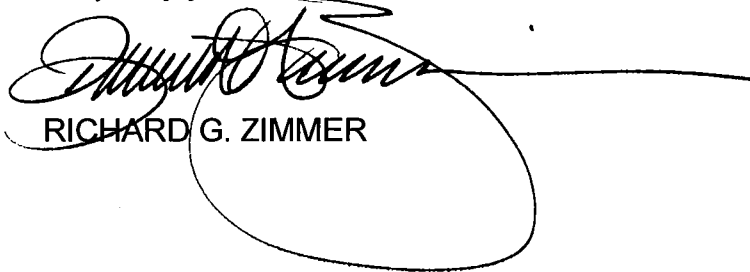

Dear Counsel:

This correspondence is in reference to Bolthouse Special Interrogatories directed to return flows from native water which were due on January 10, 2014. Our records indicate that the following parties have not responded in any manner. Additional parties have either objected on the grounds that they do not understand the scope of the inquiry or do not believe that return flows from native water are at issue for the next phase of trial. (See Exhibit A.)

Please note that this discovery is directed only to claims of return flows from native water such as the claim being made by Phelan Piñon Hills. At one of the last case management conferences, the Court clarified that return flow claims based upon treatment of groundwater, such as that being made by L.A. Sanitation and possibly Lancaster, would not be part of the Phase 5 trial. However, the claim of Phelan Piñon Hills is distinct, possibly the only claim of this type being made, and the Court previously indicated this claim would be heard in the Phase 5 trial.

We recently conducted the deposition of Phelan Piñon Hills manager Don Bartz. Based upon this deposition, more insight was gained regarding the Phelan claim. Phelan points out that the Department of Water Resources identifies part of the Antelope Valley groundwater basin extending into the Mojave Adjudication Area on the west side of the Antelope Valley Area of Adjudication. Based upon groundwater pumped from Phelan Well 14, on the eastern boundary on the Antelope Valley Area of Adjudication, and used overlying the same groundwater basin which underlies the Antelope Valley Area of Adjudication, Phelan Piñon Hills claims a return flow right.

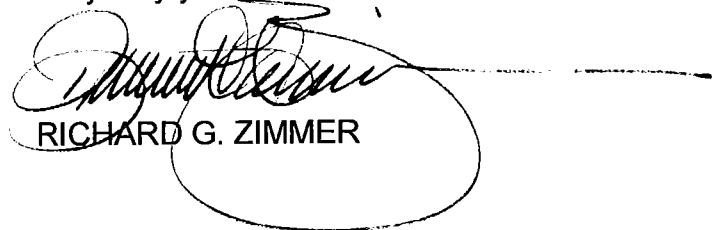

The discovery Bolthouse served is intended to determine whether any other party is making a return flow claim, similar to Phelan, based upon the idea that pumping groundwater from the groundwater basin underlying the Antelope Valley Area of Adjudication, once used, can then be claimed as a return flow. If so, such claims should be litigated along with the Phelan claim in the Phase 5 trial.

This correspondence is to meet and confer on this issue preliminary to a discussion with Judge Komar. If you have not responded to the Bolthouse discovery, please do so. If you have objected to the discovery, take this letter as clarification of the scope of the inquiry and respond appropriately. Please provide responses and/or further responses by noon on January 14, 2014.

Please feel free to give me a call if you have questions or wish to discuss this matter in more detail since it is difficult to address all issues as to all parties in a timely fashion with simply a letter. In any event, thank you for your attention to this matter.
