I, Wendy Y. Wang, declare:


1. I have personal knowledge of the facts below, and if called upon to do so, I could testify competently thereto in a court of law.

The Court confirmed the order of proof shall be as follows:

**August 3, 2015 at 9:00 am (Los Angeles)**

The Court confirmed that the Final Fairness Hearing (Wood Class Action Settlement) will be heard in Los Angeles.

**August 4, 2015 at 9:00 am (Los Angeles)**

The court finds good cause to grant an order shortening the time to file the opposition to the global settlement by the Willis Class regarding the legal effect of the global settlement on the Willis Class Settlement and Judgment; said opposition to be filed by Attorneys Kalfayan and Brennan on July 15, 2015; Response thereto shall be due by July 24, 2015; any reply shall be filed by July 29, 2015; and the hearing shall be heard on August 4, 2015 at 9am in Los Angeles. The court will not take evidence at this time other than the documents making up the settlements and judgments.

**August 25-27, 2015 at 9am (each day) (San Jose)**

There being no objection, the Court confirmed that the hearing on the claims by Phelan Pinon Hills CSD will be heard in San Jose; department TBA. Simultaneous trial briefs shall be filed by August 17, 2015; supplemental trial briefs may be filed by August 24, 2015.

**September 4, 2015 at 1:30pm (via CourtCall)**

The Court set a further status teleconference call on September 4, 2015; all parties, including the Court, to appear telephonically, via CourtCall.

**September 28-October 16, 2015**

The Court confirmed that the evidentiary hearing will be heard in Los Angeles; department TBA, and will include, but not limited to, the non-stipulating parties' prove-up; presentation of physical solutions and objections thereto; and evidence in the default proceedings. Trial briefs shall be filed by September 22, 2015.

**OTHER**

The request by Antelope Park Mutual Water Company and Tierra Bonita Mutual Water Company (Attorney Michael Duane Davis) for Correction of Minute Order re Evidence Admitted at Phase 4 Trial was submitted to the Court on June 17, 2015. The Court deferred this request to September 28, 2015 and requested that counsel submit a proposed order to the Court.

Parties are notified that the Court will be dark from August 5-21, 2015. Any issues raised during this time should be directed to Rowena Walker at (408) 882-2286 and every attempt will be made to reach the Court.

Post hearing, the Court noted that at the hearing on May 15, 2015, Sunpower's unopposed request for an order substituting Sunpower in for SGS Antelope as a party to this action for all purposes was conditionally granted, pending the lodging of the deed of transfer with the Court. The Court notes that the online docket confirms the filing of the Declaration of Scott Piscitello on June 17, 2015; the condition has been met and the request is therefore **granted**.


