### **AVEK** water users consuming twice as much ground water

Valley-East Kern are consuming twice as much groundwater each year as is being replaced, according to a U.S. Government source.

William Hardt of United States Geological Survey says this "overdraft" is the reason why underground water levels in nearly all localities in this region have been steadily dropping and will continue to drop unless supplemental water from the State Water Project is put to use here.

Hardt says the primary sources of local groundwater replenishment are run-off from the nearby mountains and pumped water that eventually returns to the underground. He claims there is no inflow of groundwater from

Water users in Antelope outside Antelope Valley-East Kern. He disputes the notion that water from the High Sierras finds its way into local groundwater basins.

> The two major sources of groundwater in Antelope Valley are flows from Big Rock and Littlerock Creeks in South Antelope Valley, Hardt explains. These streams contribute an average yearly replenishment of 27,000 acre feet, as compared with the pumping of nearly 200,000 acre feet from the total basin during the latest year of rec-

Hardt says well tests by USGS show the greatest longterm decline in the groundwater level is occurring in the Lancaster area.

As the groundwater level drops, according to Hardt, the amount of water that can be extracted per foot of well depth also declines. He warns that water quality deterioration becomes a greater threat an underground water basin nears exhaustion.
