22 **IT IS ORDERED:**

23 The Phase 3 trial shall commence on Monday, September 27, 2010, at 9:00 a.m. in  
24 Department 1. It shall be a court trial. Estimated length of trial is 10-15 days. This phase will concern  
25 the status of the groundwater basin, taken as a whole, including safe yield of the groundwater basin and  
26 whether the groundwater basin is in a condition of overdraft. The parties asserting the existence of  
27 overdraft have the burden of proof on that issue.

The following deadlines are established:

1. June 30, 2010 is the deadline for completing non-expert discovery for this phase of trial.
2. July 1, 2010 is the deadline for disclosure of expert witnesses and expert witness reports. All parties intending to present expert testimony at trial shall be required to file written expert reports. The report must contain a complete statement of all opinions the witness will express, the basis and reasons for the opinions, the data and other information the witness considered in forming the opinions, and the witness's qualifications.
3. July 21, 2010 is the deadline for a party to designate supplemental expert witnesses, but only as allowed by Code of Civil Procedure §2034.280 and applicable case law. The disclosure shall be accompanied by a written expert report as provided above.
4. Depositions of experts are to be taken between July 15, 2010 and August 30, 2010.
5. September 15, 2010 is the deadline for the submission of the following, which shall be posted on the Court's website:
  - a. Witness lists, including estimated length of testimony and any legitimate restraints on availability.
  - b. Trial exhibits.
  - c. Trial briefs.
  - d. Motions in limine.
