On July 31, 2017, Petitioner Granite Construction Company (“Granite”) submitted a Petition to the Coordination Trial Judge, Hon. Jack Komar (Ret.), pursuant to CCP section 404.4 and CRC Rule 3.544, to coordinate the add-on case entitled *Little Rock Sand and Gravel, Inc. v. Granite Construction Company, et al.*, filed March 6, 2017, in the Superior Court of California, County of Los Angeles, Case No. MC026932 (the “add-on case”), with the previously coordinated and consolidated *Antelope Valley Groundwater Cases*, JCCP No. 4408, and for an immediate stay pending decision on the Add-On Petition.

Good cause having been shown, the time for hearing and briefing is shortened as follows: objections and/or responses to the add-on petition shall be due by 5:00 p.m. on September 6, 2017; the hearing shall be heard telephonically, via CourtCall, on September 8, 2017 at 9:00 a.m.

In the interest of judicial economy and to avoid duplicative efforts in these various cases, it is hereby ordered that all proceedings in this add-on action are stayed. This stay shall expire ten (10) days after a ruling by Coordination Judge on the Petition for Add-On Coordination and Request for Stay.

Petitioner is directed to serve a copy of this order on all parties in the included coordinated actions and the clerk of each court for filing in each included action.

Pursuant to Rule 1524, the clerk of each court in which an included action is pending is directed to file this order in the included actions.
