**TO THE COURT, ALL PARTIES, AND ATTORNEYS OF RECORD:**

Cross-Defendant West Valley County Water District ("West Valley") hereby joins in the  
Public Water Suppliers' Case Management Conference Statement filed September 3, 2015.

West Valley is a signatory to the Stipulation for Judgment and Physical Solution ("Physical Solution") that this court will consider in the Phase 6 Prove-Up Trial beginning September 28, 2015. Not having been a named party and therefore not being a participant in the Phase 4 trial in July 2013, and not having its pumping history and usage approved by the court, on June 8, 2015 West Valley filed an authorized Declaration containing West Valley's water usage records and pumping history, which was submitted in lieu of proposed live trial testimony. West Valley's water usage history has previously been provided to and accepted by the other Public Water Suppliers who stipulated and agreed that upon approval of the Physical Solution, West Valley is to receive Non-Overlying Production Rights to 40 acre-feet of water per year, as described in Section 3.5.21 and Exhibit 3 of the Physical Solution, and is inclusive of the separate agreement between West Valley and the Public Water Suppliers of March 12, 2015 whereby West Valley is also authorized to produce up to an additional 35 acre-feet per year from any unused Federal Reserved Water Right Production allocated to the Public Water Suppliers under Section 5.1.4.1 of the Physical Solution.
