		STATUS CONFERENCE STATEMENT AND OBJECTIONS				

Cross-Complainant, Public Water Suppliers, filed a First Amended Cross-Complaint for declaratory relief and adjudication of water rights, and recently named several roe cross-defendant, including Milana. Milana was just recently served with summons and cross-complaint, and Milana only filed an Answer to the First Amended Cross-Complaint on Friday, August 29, 2014. With Monday being Labor Day holiday, counsel for Milana has been attorney of record for only a few days.

Notwithstanding the fact that Milana has just appeared in this case, Milana's counsel has just learned of a court-ordered meet and confer session at Attorney Jeffrey Dunn's office to be held on Wednesday, September 3, 2014. Counsel for Milana managed to appear via telephonically at the meet and confer session. During the call, the attorneys present spoke at length about various issues in the case, including the issue of Wood Class Attorneys' Fees. The attorneys also spoke about a follow-up status conference before Judge Kormar to take place on September 5, 2014.

Counsel for Milana asked if there was any way that Milana could quickly "get up to speed" in this case by being briefed or directed to the court file which would allow Milana to determine why it was brought into this case and whether Milana has any objections to any proposed settlement agreements, if any, reached in this case. Opposing counsel indicated on the call that there was no way for Milana to get up to speed quickly.

Accordingly, Milana now makes this general objection, to wit: (1) Milana just appeared in this action on August 29, 2014, (2) having just answered, Milana has had *no opportunity* to do any investigation or discovery into the claims being made in this action, and (3) Milana has had *no opportunity* to do any investigation into the terms of any proposed settlement agreement that may have been reached by the parties herein. As such, Milana objects to, and does not consent to, any proposed settlement agreements being proposed by the parties to the court, and objects to any rulings being by the court that affect Milana, when Milana has had no opportunity to investigate and meaningfully and intelligently respond to said proposed settlements and/or adjudication of rights. Making any rulings or adjudication of rights without
