"PROPERTY" means (a) a parcel of real property located within the BASIN that is 100 acres or more and is not served water by any of the PUBLIC WATER SUPPLIERS, or (b) a collection of parcels that constitute 100 acres or more, are owned by a common PROPERTY OWNER, and are not served water by any of the PUBLIC WATER SUPPLIERS.

"PROPERTY OWNER" means the person(s)or entity(ies) believed to hold or actually holding some or all of the fee interest in PROPERTY.
