I, Cindy Barba, declare:

- 1. I have personal knowledge of the facts stated below, and if called upon as a witness to do so, I could and would testify competently thereto in a court of law.
- I am a paralegal in the law firm of Krause Kalfayan Benink & Slavens, LLP, Class
 Counsel and attorneys of record for the Willis Class.
- 3. In the course of performing my duties at the law firm, I was asked by Mr. Kalfayan and Ms. Brennan to review and compare the Wood Class list of class members (emailed by Mr. McLachlan to Mr. Kalfayan on June 19, 2015) to the Willis Class list contained in the avgroundwater.com (Willis Class) website and related database. The printed Wood Class list totaled 79 pages. The Willis Class list and database contains 18,750 names. It is my understanding the avgroundwater.com website and related Willis Class database is administered and maintained by the law firm of Best Best & Krieger.
- 4. The comparison of Class lists is very detailed, time-intensive, and laborious and is still ongoing. Thus far, I have compared pages 1 to 16 of the Wood Class list to the Willis Class list. If I found a Wood Class Member who is also a member in the Willis Class list, then I marked that name with a "yes." If the Wood Class Member was not on the Willis Class list, then I marked the name with a "no." I also made sure that all persons marked with a "yes" had the same address on both the Willis Class and Wood Class list, just to be sure that I have the correct person in both lists. The vast majority of the addresses matched up.
- 5. In comparing the first 16 pages of the Wood Class list, I counted a total of 916 Wood Class Members. Out of the 916 names, I marked 713 with a "yes" and 203 with a "no." Therefore, approximately 78% of the Wood Class Members that I compared are also on the Willis Class list.
 - 6. I also was asked to confirm whether Wood Class Member Olaf Landsgaard is on

1	both the Willis and Wood Class Lists. I was able to confirm that in fact Mr. Landsgaard is on both	
2	the Willis and Wood Class list.
