### TO ALL PARTIES AND TO THEIR ATTORNEYS OF RECORD:

Cross-Defendant, CLAN KEITH REAL ESTATE INVESTMENTS LLC, DBA LEISURE LAKE MOBILE ESTATES ("Leisure Lake") hereby submits the following Trial Brief for the Phase VI [Prove-Up] Trial proceedings. Leisure Lake's Declarations, and accompanying exhibits, in support of the Phase VI [Prove-Up] Trial are submitted concurrently. This Trial Brief is made in support of the [Proposed] Judgment and Physical Solution filed with the court on March 4, 2015.

- 1. **PARTY:** Leisure Lake is a Delaware limited liability company, its principal place of business at 1835 West Chandler Boulevard, Suite 100, Chandler, Arizona 85224.
- 2. **PROPERTY:** Leisure Lake owns and operates the Leisure Lake Mobile Estates property, consisting of approximately 138 acres of real property overlying the Antelope Valley Groundwater Basin, consisting of Los Angeles County Assessor's Identification Numbers ("AIN"): 3116-015-002 (28+ Acres), 3116-015-003 (29+ Acres), 3117-007-001 (81+ Acres), and located at 48303 North 20th Street West, Lancaster, California (the "Property"). The Property includes a 211-space mobile home park, a man-made lake, an approximately 36,000-gallon swimming pool, an approximately 600-gallon spa, a community laundry room, a clubhouse area, and landscaping (the "Park").

#### **3.** CLAIMS TO GROUNDWATER PRODUCTION WITHIN THE

**ADJUDICATION AREA:** Leisure Lake claims the right to produce and use groundwater to serve the Property. The minimum amount of groundwater produced from the Property, measured in acre feet, for the calendar years 2003–2015 is as follows:

**DETERMINATION OF PRODUCTION:** Leisure Lake determined the 4. amount of groundwater produced from the Property from well logs, meter records and annual reporting. Leisure Lake is in the practice of recording the meter readings for the three wells on the Property and has well logs available from 2003 through 2015. Leisure Lake has also reported its use of groundwater to the State Water Resources Control Board and has annual reports available from 2009 through 2014.

5. **WATER USE:** The groundwater produced from the Property for the calendar years listed above was used for the provision of domestic water service to residents at the Park and for the maintenance of a man-made lake. The domestic purposes to which Leisure Lake puts its water is the highest use under Water Code section 106 ("the use of water for domestic purposes is the highest use of water"). The use of groundwater to maintain the lake is a beneficial use of water pursuant to California Code of Regulations section 668 (beneficial use of water includes "water for resorts or other recreational establishments, boating, swimming, and fishing").

#### 6. SUPPORTING INFORMATION AND DATA:

- Declaration of Jerry Delucia In Lieu of Testimony for Phase VI Trial, filed concurrently hereto. Jerry Delucia is the former Maintenance Supervisor and Chief Operator of the water system at Leisure Lake and his declaration demonstrates historical use of groundwater on the Property.
- b. Declaration of Charles M. Keith In Lieu of Testimony for Phase VI Trial, filed concurrently hereto. Charles Keith is the General Manager of Clan Keith Real Estate Investments, owner of Leisure Lakes, and his declaration demonstrates longstanding residential and recreational use of groungwater on the Property.
- 7. **OFFER OF PROOF:** Leisure Lake offers the Declaration of Jerry Delucia In Lieu of Testimony for Phase VI Trial and the Declaration of Charles M. Keith In Lieu of Testimony for Phase VI Trial to establish the facts declared therein and asks the Court to admit the facts therein declared into evidence to establish Leisure Lake's claims and rights under the
