In accordance with the Court's order of July 11, 2006, the State of California submits the following expert witness information with respect to the July 24, 2006 hearing to determine an adjudication boundary for the Antelope Valley Groundwater Basin:

The identity of each witness intended to be called to testify.

The State intends to call Robert L. Pierotti, Supervising Engineering Geologist with the California Department of Water Resources (DWR), Southern District. Mr. Pierotti is a California Professional Geologist, a California Certified Engineering Geologist, and a California Certified Hydrogeologist.

2. A short statement summarizing the nature of said witness' testimony.

Mr. Pierotti will testify with respect to the subject matter of his declaration, filed on June 29, 2006, including the following topics:

- a. The ongoing role and responsibility of DWR in preparing and publishing Bulletin 118, *California's Groundwater*, last updated in 2003;
- b. DWR's analysis of the Antelope Valley Groundwater Basin, including its hydrogeologic boundaries, for Bulletin 118 (2003).
- c. Sources used by DWR in analyzing the boundaries of the Antelope Valley Groundwater Basin, including groundwater contour maps, geologic maps, gravity maps, paleogeographic maps, studies and other literature, well completion reports, and additional information that has been discovered since the 2003 update of Bulletin 118.

In addition, Mr. Pierotti may be called by the State as a rebuttal witness to testify in response to the expert testimony presented by other parties.

3. The estimated length of time of such witness' direct testimony.

The State estimates that Mr. Pierotti's direct testimony will last approximately one and one-half hours.
