- 16 5. 5-USAF-126 – 5-USAF-140 are exhibits that are pertinent to June Oberdorfer’s
17 testimony. Dr. Oberdorfer’s exhibits also contain blank pages due to file size. The
18 United States is attempting to remedy the problem, and will further amend the
19 exhibits list and submission at a later date. Dr. Oberdorfer is identified as a possible
20 rebuttal witness and is not expected to testify during the 2 days of scheduled trial,
21 February 10 and 11, and therefore, these exhibits will not be part of the United States’
22 initial case-in-chief.
- 23 6. 5-USAF- 257 is an additional trial exhibit and is included as Attachment 4.
- 24 7. 5-USAF- 258 is an additional trial exhibit and is included as Attachment 5.
