MR. DUNN AGAIN. THE DISCUSSION LAST NIGHT WAS THAT

WE'RE ALL HERE FOR THIS PHASE FIVE TRIAL. WE CAN TAKE

ADVANTAGE OF EVERYONE BEING HERE AND WORK ON THIS

SETTLEMENT. THAT'S THE DISCUSSION, THE CONCEPT. WE'RE

HERE; WE CAN WORK ON THAT.

AGAIN, THE PHASE FIVE TRIAL ISSUE ON RETURN FLOWS MOSTLY INVOLVES DISTRICT 40 AND AVEK. I KNOW MR. FIFE HAS A STAKE IN THAT AS WELL. BUT GIVEN THE RESOLUTION OF THAT BETWEEN AT LEAST THESE TWO PARTIES, IT SEEMS TO THE GROUP LAST NIGHT -- THERE WAS ONE EXCEPTION -- THAT IT MAKES MORE SENSE NOW, IN TERMS OF WORKING ON THE RETURN FLOW ISSUES, TO WORK ON THE GLOBAL RESOLUTION.

THE COURT: WELL, ONE OF THE QUESTIONS THAT I HAVE

AND ONE OF THE CONCERNS THAT I HAVE IS THE SETTLEMENT

POINTS, TO THE EXTENT THAT THERE ARE A NUMBER OF ISSUES

THAT ARE BEFORE THE COURT, NOT JUST IN FIVE, BUT ALSO IN

SIX, PHASE SIX, AS WELL AS THE POTENTIAL AFTERMATH OF A

JUDGMENT, WHICH OBVIOUSLY IS NOT GOING TO BE ABLE TO

ADDRESS ANYTHING OTHER THAN, IN A GENERAL WAY, THE

AND HAVE NOT ONLY NOT SEEN IT, BUT I'M NOT EVEN SURE
THEY KNOW THAT IT EXISTS.

SO WE HAVE A LONG WAY TO GO AND WE HAVE A LOT TO DO. AND WE HAVE BEEN IN POSITIONS BEFORE WHEN WE WERE CLOSE, AND WE'VE BEEN IN THAT POSITION MANY TIMES THROUGHOUT THE TEN YEARS THAT I'VE BEEN INVOLVED IN THE CASE.

SO THOUGH WE ARE ENCOURAGED BY IT AND WANT TO PARTICIPATE, WE NEED TO KEEP MOVING FORWARD ALSO WITH THE RECOGNITION OF THE HISTORY OF SETTLEMENT EFFORTS IN THIS CASE, AND ALSO RECOGNITION, AS HAS BEEN SAID MANY TIMES OVER THE YEARS, THAT WHAT PUSHES SETTLEMENT THE MOST IS HAVING OUR FEET TO THE FIRE, FIRM DEADLINES AND CONSEQUENCES IF WE'RE NOT MOVING FORWARD, AND THAT TAKES

I FAVOR A DATE CERTAIN ALSO FOR THE RESUMPTION OF THE PHASE FIVE TRIAL. AS MR. LEININGER POINTED OUT, THERE'S STILL SOME DISCUSSION WHETHER THAT SHOULD BE TWO WEEKS FROM NOW OR SIX WEEKS FROM NOW, AND OF COURSE THE COURT'S CALENDAR COMES INTO IT AS WELL, BUT NOBODY WANTS A LONG TIME.

THE COURT: I CAN ASSURE YOU IT'S NOT GOING TO JUST GO OFF CALENDAR, NO MATTER WHAT HAPPENS.
