Here are the answers to your questions:

- 1. AVEK can provide the requested letter as to min/max flows but keep in mind, as with all of our turnouts, supply is secondary and interruptible with no guarantee as to flow rate or quantity. I'm required to include these facts in the letter. I'll send a draft over shortly.
- 2. Upon reviewing the Water Service Agreement, there is no language as to specific turnouts but only generically "connections". I believe this was done on purpose so that additional turnouts could be added without having to amend the original agreement. We have added many connections with various customers over the years without amending the original agreements thus no amendment will be necessary.

I just gave AECOM clearance to obtain the title report to move forward with negotiations on the easement. I'll send along the results of their negotiations as soon as they are available.
