ORDER GRANTING APPLICATION OF COPA DE ORO LAND COMPANY FOR APPROVAL OF STIPULATION REGARDING FACTS PERTAINING TO COPA DE ORO LAND COMPANY FOR TRIAL

On March 25, 2013, at 9 a.m. in Department 1 of the Los Angeles County Superior Court, Central District, located at 111 North Hill Street, Los Angeles, California 90012, the application of cross-defendant Copa de Oro Land Company ("Copa de Oro") for approval of a Stipulation Regarding Facts Pertaining to Copa De Oro Land Company For Trial (the "Ownership Stipulation") among Copa de Oro and Los Angeles County Waterworks District No. 40 ("District 40") and Palmdale Water District ("PWD") came on for hearing, the Honorable Jack Komar presiding. - (2) No party has demonstrated that there is an evidentiary dispute concerning those facts.

Accordingly, GOOD CAUSE APPEARING, the Court orders as follows:

The facts stated in the Joelson Declaration are accepted as facts proven at trial and shall be binding on all parties in this action.
