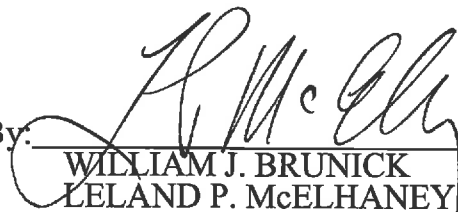
1 **TO THE PARTIES ABOVE NAMED AND THEIR COUNSEL OF RECORD:**

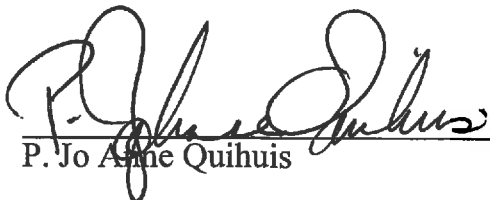
