**SUPPLEMENTAL DECLARATION OF

1 I, Thomas Barnes, declare:

2 1. I am the Resources Manager for the Antelope Valley - East Kern Water Agency (AVEK), a
3 party to this action. I have personal knowledge of all of the matters set forth herein and, if called as a
4 witness, I could and would testify competently thereto.

5 2. Attached as Exhibit 1 hereto is a true copy of the "Antelope Valley East Kern Water
6 Agency Aerial Crop Information for Beneficial Uses" report prepared by AVEK's expert
7 witness, Dr. Hong-lie Qiu. (See Dr. Qiu's previously filed declaration.) Therein, Dr. Qiu sets
8 forth his calculations of total water usage on AVEK owned properties based upon (a) his
9 analysis of Landsat images from which he determined acreage farmed and crops grown, and
10 (b) the crop water duty information I provided to him (see Exhibit 2 attached hereto).

11 3. Attached as Exhibit 3 hereto are additional records prepared by me which set forth the
12 amount of water delivered to the same AVEK owned properties, to supplement water pumped
13 for agricultural use.

14 4. The amount of water pumped on the AVEK owned properties in 2011 and 2012, is
15 determined by subtracting the amount of delivered water from total water usage (i.e., total
16 usage - delivered water = pumped water). Exhibit 4 hereto, marked Table #1, demonstrates that
17 the amount of pumped water was 12,678 AF in 2011, and 3248 in 2012 (based upon crop water
18 duties of 7.0 AF for alfalfa and 4.5 AF for onions).

19 5. Exhibit 5 hereto, marked Table #2, shows that pumped water was 11,464 AF in 2011,
20 and 2,790 in 2012 (based upon crop water duties of 6.5 AF for alfalfa and 4.5 AF for onions).

21 I declare under penalty of perjury under the laws of the State of California that the
22 forging is true and correct, and that this declaration was executed in Palmdale, California, on
23 May 24, 2013.

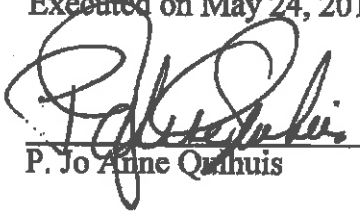
