#### Thanks, Kate.

This is really tricky because there is so much uncertainty with this area. I looked at our <u>contours</u> to see if a good bit of recharge is coming across the fault in this area, but it seems pretty inconclusive because there are so little data out <u>here</u> (note the few wells used to create the contours in the annual report).

I wrote a <u>summary of the analysis they included</u> in the application, but I didn't feel comfortable coming to any conclusions about material injury. I am hesitant to give too much weight to the analysis they included. It feels like a shot in the dark basing it on nearby wells because the area is so discontinuous from faulting and exposed bedrock. Additionally, the drawdown analyses used 20 gpm for the pumping rate, while the well design estimated is for 25-150 gpm.

The fault could potentially mean less material injury to the Central Antelope Subbasin, but there's a lot of uncertainty there. Additionally, it's challenging to justify 36 acres of new irrigated agriculture from a new party in an area with little historical pumping that's technically in the Central Subbasin. I recognize that this is the sort of geologic setting where I think our guidance is extremely important for the Board, which makes the high level of uncertainty challenging.

The housing portion of the project is estimated to only use ~9 AFY. The housing portion of the project is extremely efficient and is a clear beneficial use to me. There could be room for the total amount of water for the ag portion of the project to be reduced. Let me know if there is anything I can do to move this forward in the next day to get it on the October Agenda. Otherwise, we may need to wait until the Nov/Dec meeting. Arden

I am working on the Barrel Springs New Production Application. This is for an affordable housing community for ag workers with 36 acres of orchards and row crops on the property, and they are requesting 120 AFY. We just got some water use details today, and I was hoping I can wrap up the letter by tomorrow morning.

However, one big detail I had overlooked is that the San Andreas fault (and several branches) runs right through the parcel. The parcel is in the bottom of the Central Antelope Subbasin. It is south of the USGS Antelope Model Boundary.

How much of hydrogeologic barrier do we expect the San Andreas to be? The application includes an analysis by Geosyntec about how the well (pumping 120 AFY) may affect the water levels nearby, but it only mentions the San Andreas as a "partial hydrogeologic barrier." It addresses the effects of pumping on nearby wells, but does not address how connected the well may or may not be to the rest of the Antelope Subbasin.

I'm interested in your thoughts on a few items:

- 1. Do we have any information about how pumping S of the San Andreas affects storage in the Antelope Subbasin? Was an analysis conducted in conjunction with the adjudication boundary determination?
- 2. Have we completed any previous New Production Reports in areas along the San Andreas Fault?
- 3. Are there any questions we need to ask of Barrel Springs? Perhaps where the well will be located within the parcel?

Thanks, but I need to learn to swim without my life preserver...I'll check in with you after I'm done to make sure it looks ok.

Are you planning to be at the Dec 7 meeting? Do you have any applications other than two Calandri transfers?

FYI – I looked at Barrel Springs some more...if the low transmissivity is still applicable to the aquifer, then even with 55 gpm, a pumping well could increase drawdown up to 40 feet in a well 1,300 feet away. If that is a small domestic well, 40 feet could be a problem for that well. But the buildings on the parcel with that "closest" well don't look like a house to me. Dudek seems to think that it is a domestic well (because of the 1AFY number that they say the well "is limited to"). The residential property 1,300 feet the northwest appears to be served by PWD – according to that parcel map. So, it is only this one well that is an issue.

However, I suspect that the faulting separates Barrel Springs from other wells north of the aqueduct and will probably conclude in the letter that, given the small amount of production for the well and the uncertainty associated with the closest well, MI is not likely. But I do hope that they do more work on the new well (aquifer test) – maybe I'll make that as a condition for approval. FYI – the closest cross section in the Expert Report illustrates the local compartmentalization and faulting pretty well – I might use this as an illustration (Figure) for the application. FYI – the applications budget now has no prayer of recovering now with my hours on Barrel Springs. But I do think that there is potential for problems here and don't want to approve this without thinking...just wish we knew more about the nearby well (and if that really is a house!!).

Phyllis, to continue my last email – looks like you have the letter open so here are my suggested corrections to address the typo for addition to the letter.

Todd Groundwater's letter (dated May 10, 2022) recommending approval of this transfer listed four existing wells on four parcels (APNs 244-040-03, 244-040-021, 244-040-17, and 244-010-36) that would supply water to the project. During this recent review, a typo was noticed in the letter: APN 244-040-17 should actually be APN 244-040-12. This change makes no impact on the Material Impact analysis nor on the adopted resolution (R-22-30) which includes both of these parcels. During recent field investigations, it was discovered that another existing groundwater well is located within the project site on APN 244-040-15. The solar contractor's representative, Dudek, contacted Todd Groundwater to see if this well (State Well ID 10N/08W-02M01) can be added to the list of potential New Point of Extraction wells. This parcel is also listed on the Exhibit A Attachment to the Resolution for Adoption (R-22-30) as Parcels Water Transferred to.

FYI – I looked at Barrel Springs some more...if the low transmissivity is still applicable to the aquifer, then even with 55 gpm, a pumping well could increase drawdown up to 40 feet in a well 1,300 feet away. If that is a small domestic well, 40 feet could be a problem for that well. But the buildings on the parcel with that "closest" well don't look like a house to me. Dudek seems to think that it is a domestic well (because of the 1AFY number that they say the well "is limited to"). The residential property 1,300 feet the northwest appears to be served by PWD – according to that parcel map. So, it is only this one well that is an issue.

However, I suspect that the faulting separates Barrel Springs from other wells north of the aqueduct and will probably conclude in the letter that, given the small amount of production for the well and the uncertainty associated with the closest well, MI is not likely. But I do hope that they do more work on the new well (aquifer test) — maybe I'll make that as a condition for approval. FYI — the closest cross section in the Expert Report illustrates the local compartmentalization and faulting pretty well — I might use this as an illustration (Figure) for the application. FYI — the applications budget now has no prayer of recovering now with my hours on Barrel Springs. But I do think that there is potential for problems here and don't want to approve this without thinking...just wish we knew more about the nearby well (and if that really is a house!!).

Arden and Kate – I reviewed (and edited) the applications for the January AVWM Board meeting. Arden – are you going to handle the submittal of applications to Hallmark? Do you know who to email them to?

I had a few comments on some of the applications – just for your consideration before defending them at the AVWM meeting.

- I did even more editing on <u>Barrel Springs</u> that I had done previously. I wanted to make it clearer that we are recommending the application be approved with the condition that they provide us with well information and testing data. I don't think it is fair to the applicant to make the analysis of the new well a condition of approval. We can use the information to better inform ourselves about the area and to analyze any future unanticipated impacts. I don't think that we really know where the closest domestic well is located, but my best guess on available data is that it is more than 2,000 feet away from the proposed well location and won't be impacted by that local pumping. We learned from PWD that the wells to the north and northwest are served by the District and would not have domestic wells to impact.
- <u>Galdamez new production</u> wants 2AFY for one mobile home and tiny irrigation. We may be asked to defend why she gets 2AFY when it doesn't seem like she needs it.
- Long Valley new production: the information about the two hydrographs doesn't conclude anything about declining water levels near Long Valley. The map on Figure 2 begs the question of what water levels look like in monitoring wells that are even closer to the property than discussed in the letter. I moved the information about "no reported MI in this area" with the current pumping. However, it would still be good to look at water level data in closer wells before the meeting. If those wells don't have recent data, we can just say so.
- <u>Phillips new production</u>: the "safety factor of 2.55" proposed by Duke Engineering is brand new and inconsistent with what we've done for other applicants. How is that justified? Our charge is to make sure that the water requested is consistent with the water use proposed. So, this adds a new wrinkle. The Board will likely question this.

- Long Valley No changes I can't remember exactly why this was tabled was it the issue of RW not being guaranteed? If so, I guess Craig's memo will handle it.
- Barrel Springs- No Changes I resisted the temptation to re-write that letter again. I'm going
  to wait to see what the Advisory Committee says about this to be ready to respond at the
  Board meeting if needed.
- Lee Very straightforward domestic well good.
- Mendez and Ledesma boundary cutting through parcel letter makes it sound like we know that the well will be drilled on the hill is that the case or is that our assumption (I suspect that assumption is correct, but I just wanted to know)? For most of our domestic well applications, the actual well location has not yet been determined (correct?), and we have been fine with that in the past. I agree that it should be a condition for some projects, but we didn't think that whether or not the well would be productive was a material injury concern for this well. We considered it after the advisory committee meeting, but I couldn't find any evidence that it would affect nearby wells or cause material injury as defined in the Judgment. Further, their lawyers had expressed that they would resist requiring the pumping test results as a condition for approval (though they would do the pumping test and provide us with the data).

Prior to Kathy's concerns about consolidation, expressed after the vote, I was under the impression that if they couldn't produce the water needed to move forward with the project, it would be an issue only for Barrel Springs.
