- 1. I am the Manager of Oro Vista Farms, LLC, a California limited liability company, the Movant herein. I have personal knowledge of the matters set forth herein, and if called as a witness, I could competently testify thereto. A true and correct copy of the Watermaster Engineer's January 8, 2025 Letter to the Watermaster Board regarding its review of the Transfer Request by RTS Orchards, LLC is attached hereto as Exhibit "B" and is incorporated herein by this reference.
- 5. I am informed and believe that the Transfer Request came on for hearing during the course of the Watermaster Board meeting on January 22, 2025, and that after a thorough discussion and consideration of the matter the Board voted unanimously to approve the transfer request.



Watermaster Board:

Todd Groundwater finds that the attached application for a permanent transfer of 1 AFY of Production Rights from RTS Orchards, LLC, to Oro Vista Farms, LLC (Oro Vista Farms), is complete, provided Oro Vista intervenes in the Judgment. RTS Orchards is an Exhibit 4 Party with wells in the West Antelope Subarea (**Figure 1**). Oro Vista Farms is not a Party to the Judgment but would like to buy the Production Right and to become a Party to the Judgment after intervention.

RTS Orchards, LLC, currently has a Production right of 1,494 AFY. It produced 1,156.86 AF in 2023.

Oro Vista Farms intends to use this water on the property owned by RTS Orchards. If Oro Vista received a transfer and plans to produce more than 1 AFY on RTS Orchards' property, a Material Injury analysis will be conducted that considers the cumulative planned production by both Oro Vista and RTS Orchards. If Oro Vista Farms and RTS Orchards produce from the same well, the two Parties must coordinate their metering and production reports so that the total water produced is reported and appropriately designated to each Party.

This transfer does not represent a change in location of the Production Right. Due to the low volume of water, Todd Groundwater finds the potential for Material Injury to be negligible. Todd Groundwater recommends the approval of this application on the condition that Oro Vista Farms intervenes.





WHEREAS, the Antelope Valley Watermaster, formed by the Antelope Valley Groundwater Cases Final Judgment ("Judgment"), Santa Clara Case No. 1-05-CV-049053 signed December 23, 2015, is to administer the Judgment; and

WHEREAS, a process for considering and approving applications for transfers is set forth in the Judgment and in the Rules and Regulations unanimously adopted by the Board on June 24, 2020 pursuant to Resolution No. R-20-12; and

WHEREAS, the Watermaster Engineer is authorized under the Judgment to recommend to the Watermaster Board that applications for transfers be denied or approved and that approval may be pursuant to certain conditions; and

WHEREAS, pursuant to the terms of the Judgment, the Watermaster Engineer is required to make certain findings and to consider, investigate and recommend to the Watermaster Board denial or approval, or approval with certain conditions, of these applications consistent with the terms of the Judgment; and

WHEREAS, pursuant to the Transfer Request Form listed on attached Exhibit A, RTS Orchards, LLC proposes to make permanent transfers of 1 acre-foot to Oro Vista Farms, LLC; and

WHEREAS, Oro Vista Farms, LLC is not a Party to the Judgment, and as such Oro Vista Farms, LLC may not receive a transfer of Production Right until they successfully intervene as Parties to the Judgment; and

WHEREAS, in consultation with the Watermaster General Counsel, the Watermaster Engineer has reviewed the Application and, if the Board chooses to approve the Application, recommends that approval be subject to the following conditions, as noted on Exhibit A:

- (1) Oro Vista Farms, LLC must file a motion to intervene as a Party to the Judgment no later than thirty (30) days after the date of this Resolution;
- (2) the proposed transfer shall be of no force or effect until Oro Vista Farms, LLC has successfully intervened as a Party to the Judgment;
- (3) nothing in this Resolution shall be construed as precedent or authority for any non-Party to receive a transfer of a Production Right without first intervening in the Judgment.

WHEREAS, the Watermaster Board has considered the findings and recommendations of the Watermaster Engineer set forth above and attached in Exhibit A and is prepared to approve the Application pursuant to such conditions recommended by the Watermaster Engineer. NOW, THEREFORE, BE IT RESOLVED, that the Watermaster Board unanimously approves the application for transfer in attached Exhibit A to this Resolution as being consistent with the terms of the Judgment and applicable Rules and Regulations, subject to the conditions set forth in the Recitals above and attached in Exhibit A.
