3	"All private (i.e., non-governmental) persons and entities that own real property within the Basin, as adjudicated, and that are not presently pumping on their property and have not done so within the five year period preceding the filing of this action. The Class excludes the defendants herein, any person, firm, trust, corporation, or other entity in which any defendant has a controlling interest or which is related to or affiliated with any of the defendants, and the representatives, heirs, affiliates, successors-in-interest or assigns of any such excluded party. The Class also excludes all persons to the extent their properties are connected to a municipal water system, public utility, or mutual water company from which they receive water service."
