The Willis Class respectfully submits the following status conference statement. The
Willis class continues to monitor the case without actively participating in the mediation before

1 Justice Robie. The reasons behind its limited participation were discussed in its last case
2 management conference statement dated June 13, 2012. Based on the most recent filing of the
3 Federal government it would appear that the landowner parties may be close to resolving their
4 claims with the public water suppliers. The Willis class will continue to rely on the terms of the
5 court approved stipulation of settlement in the expectation that any proposed Physical Solution
6 will fully respect the Class' correlative rights and stay consistent with the terms of the stipulation
7 of settlement. To the extent a proposed Physical Solution does not respect the Willis Class' rights
8 to use the Basin's groundwater, we will reluctantly have to oppose it.
