1. I am the named lead plaintiff and class representative in the above entitled action. I submit
this declaration in support of Plaintiff's Motion to Substitute the lead plaintiff. I am over 18 years
old and make this statement based on my own personal knowledge. If called upon as a witness to
testify to the truth of the matters contained in this declaration, I would and could competently do
SO.

- 2. I have served as the plaintiff class representative since the inception of this case, in or about 2006. Throughout that period of time I have fulfilled my duties and responsibilities to the class. The case was certified as a class action based on, among other things, my ownership of real property in the Antelope Valley. I am aware that a judgment was entered on behalf of the certified Willis class in 2011. In or about May, 2012, I sold my real property in the Antelope Valley Basin. The address of the property is AVE B VIC 200 STW, Fairmont, CA 93536. I no longer own this property or any other real property in the Antelope Valley or within the area of adjudication.
- 3. Because I have relocated from California and no longer own any property in the Antelope Valley I would like to withdraw from this litigation and substitute others as class representatives to ensure that the rights of the absent class members are vigorously prosecuted and their rights to pump groundwater in the future is protected. The law firm of Krause Kalfayan Benink & Slavens has permission to continue to use my name in the pleading in the future if they so desire for the sole purpose of designating the non-pumping landowner class.
