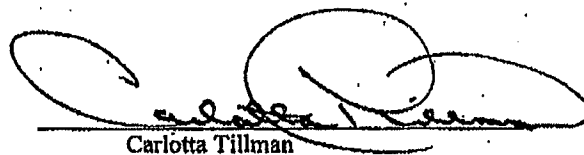

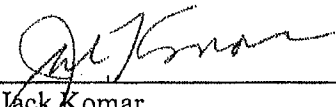

**ELECTRONIC FILING AND
SERVICE ORDER**

1 The Court hereby designates the above action an Electronic Filing (E-Filing) case, as
2 described and governed by this Order. All parties to the above case consent to the entry of this
3 Order and agree to be bound by its provision.

4 **I. GENERAL**

5 **A. APPLICABILITY OF OTHER RULES AND ORDERS**

6 Except to the extent modified by this Order, approved stipulation or other order of the
7 court, all California Rules of Civil Procedure, Local Rules, and orders of the court shall
8 continue to apply to cases which are subject to electronic filing. Electronic filing is
9 subject to the provisions of California Rules of Court 2050-2060, as those Rules may be
10 amended from time to time.

11 **B. SELECTION OF CASES**

12 All matters classified by the court as Complex Litigation may be designated for
13 voluntary e-filing by stipulation. A matter classified as provisionally complex pursuant
14 to Rule of Court 1800(c) must be filed electronically until exempted. A matter
15 designated by a party as complex pursuant to Rule of Court 1810 or 1811 need not be
16 electronically filed until such time as the court enters a classification order pursuant to
17 Rule of Court 1812.

18 **C. ELECTRONIC FILING SERVICE PROVIDER**

19 Pursuant to Rule 2055(a)(1) the Court has contracted with Glotrans to establish an
20 electronic filing system for the Court. The Website address is <http://www.scefiling.org>.

1 D. DEFINITIONS

2 The following terms in this Order shall be defined as follows pursuant to California
3 Rules of Court, Rule 2050:

4 1. E- File – Electronic transmission to a court of a document in electronic form.
5 The Court will utilize a third party vendor. An E-File consists of either an E-
6 Document, an E-Image, or both. Upon completion of an E-File to the Vendor's
7 system, an email receipt is issued to the sender acknowledging receipt by the
8 Vendor system.

9 2. E-Service – Electronic transmission of a document to a party's electronic
10 notification address for the purpose of effecting service. The Court will utilize a
11 third party vendor. Once the Vendor has served all recipients, the Vendor submits
12 a proof of service to the Court on behalf of the filer.

13 3. E-Document – A document is a pleading, a paper, a declaration, an exhibit, or
14 another filing submitted by a party or by an agent of a party on the party's behalf.
15 All pleadings and other documents which are filed electronically with the Court will
16 be filed in Portable Document Format (PDF). If a pleading or document is filed
17 electronically in a format other than PDF, it will be rejected by the Vendor as
18 defective.

19 4. E-Image – An electronic file of a document that has been scanned or converted
20 to a graphical or image format. All pleadings or other documents that are captured
21 as scanned images from paper and then filed electronically with the Court will be
22 scanned at a resolution of between 200 and 400 dpi (dots per inch) and converted to
23 PDF. Once converted, the complete contents of the pleading or other document
24 must be viewable in a PDF reader without assistance of the reader's zoom feature.

25 5. Electronic Endorsement – An electronic stamp applied to a document that is
26 filed electronically that shows the endorsement by the Court.

27
28 II. REGISTRATION AND ACCESS

 A. OBLIGATION TO REGISTER

1 At least one attorney of record for each party in the matter designated for electronic filing
2 must promptly register with Glotrans. Glotrans will assign to the user a confidential
3 login and password to the system. Additional authorized users may be added at any time.

4 B. OBLIGATION TO KEEP INFORMATION CURRENT

5 A party whose electronic notification address changes while the action or proceeding is
6 pending must promptly file a notice of change of address with the court electronically
7 and must serve this notice on all other parties or their attorneys of record.

8 **III. ELECTRONIC FILING OF PLEADINGS AND OTHER DOCUMENTS.**

9 As of the filing of the initial complaint, except as expressly provided herein, or as
10 expressly authorized by the Court, all pleadings, motions, memoranda of law,
11 declarations, orders, or other documents filed in the above-entitled case shall be filed
12 electronically through the system.

13 A. SUBSEQUENT PLEADINGS

14 The clerk will not accept or file any pleadings or instruments in paper form. Parties must
15 E-File a document either:

- 16 1. Through the Vendor's system from the filing attorney's office; or
- 17 2. By mailing or faxing all documents and attachments to Vendor. Vendor
18 shall then convert said documents and attachment to electronic form, file
19 them with the Court, and serve designated parties as provided herein.
20 Parties choosing to file through the Vendor shall be charged fees
21 reflecting Vendor's then-current published rates for filing and service in
22 this manner.

23 B. FORMAT

24 All electronically filed and served pleadings must, to the extent practicable, be
25 formatted in accordance with the applicable rules governing formatting of paper
26 pleadings. The electronic document title of each pleading or other document, must
27 include:

- 28 (a) Party or parties filing/serving the document,

1 (b) Nature of the document,

2 (c) Party or parties against whom relief, if any, is sought, and

3 (d) Nature of the relief sought

4 (e.g., Defendant ABC Corporation's Motion for Summary Judgment)

5 C. MAINTENANCE OF ORIGINAL DOCUMENTS

6 An original of all documents filed electronically, including original signatures, must be
7 maintained by the party filing the document pursuant to California Rules of Court Rule
8 2057.

9 D. COMPLETION OF FILING

10 Electronic transmission of a document consistent with the procedures adopted by the
11 court will, upon the complete receipt of the same by the Clerk and together with the
12 receipt of acceptance by the court, transmitted from the Vendor, constitute filing of the
13 document for all purposes of the Code of Civil Procedure and the Rules of Court, and
14 will constitute entry of that document onto the docket maintained by the Clerk.

15 E. FILING DEADLINES

16 Filing documents electronically does not alter any filing deadlines. All electronic
17 transmissions of documents must be completed (i.e., received completely by the Clerk's
18 Office) prior to 5:00 Pacific Time in order to be considered timely filed that day.
19 Where a specific time deadline is set by court order or stipulation, the electronic filing
20 must be completed by that time. Any document filed after 5:00 p.m. (Pacific Time) on
21 a day when the court is open for business will be deemed to have been filed on the next
22 court day. Vendor is hereby appointed the agent of the Clerk of the Superior Court as to
23 the electronic filing, receipt, service, and/or retrieval of any pleading or document in E-
24 File. Upon filing of a document the Vendor will issue a confirmation that the document
25 has been filed.

26 F. SYSTEM OR USER FILING ERRORS

27 If it is shown that the electronic filing is not filed with the court because of (1) an error
28 in the transmission of the document to the Vendor which was unknown to the sending

1 party, or (2) a failure to process the electronic filing when received by the Vendor, the
2 court may enter an order permitting the document to be filed nunc pro tunc.

3 G. DOCKET

4 The record of filings and entries generated by the courts case management system for
5 each case will constitute the docket.

6 **IV. ELECTRONIC SUMMONS**

7 On electronic filing of a complaint, a petition, or another document that must be served
8 with a summons, the party must e-file the summons together with the document. The
9 Court will then endorse the summons with an image of the Court's seal and the assigned
10 case number. The party must then serve the summons. Personal service of the printed
11 form of an electronic document has the same legal effect as personal service of an
12 original summons [Rule of Court 2059(f)]. After the summons is served, the party must
13 e-file the summons again with the proof of service. The Court will then endorse the
14 summons.

15 **V. ELECTRONIC SERVICE OF PLEADINGS AND OTHER DOCUMENTS**

16 All parties must make service upon other parties electronically through the E-File
17 system. Parties, or their designated counsel, will receive all documents E-Filed and E-
18 Served upon them via access to the Vendor's system. The exception to this general
19 order is a Motion for Determination of Good Faith Settlement. Said motions must be
20 served pursuant to Code of Civil Procedure section 877.6 (a)(2) unless otherwise
21 ordered by the Court.

22 A. EFFECT OF ELECTRONIC SERVICE

23 The electronic service of a pleading or other document will be considered as valid and
24 effective service on all participants and will have the same legal effect as an original
25 paper document.

26 B. SERVICE OF ELECTRONICALLY FILED DOCUMENTS

27 The Vendor will provide electronic service for all documents requiring service,
28 including those which are not filed with the court, as provided in Rule of Court 2060.

1 Delivery of e-service documents through the Vendor to other registered users will be
2 considered as valid and effective service and will have the same legal effect as an
3 original paper document. Recipients of e-service documents will access their
4 documents through the Vendor.

5 C. SYSTEM OR USER SERVICE ERRORS

6 If electronic service on a party does not occur because of (1) an error in the transmission
7 of the document to a party which error was unknown to the serving party or Vendor, (2)
8 a failure to process the electronic filing for service when received by the Vendor, or (3)
9 the party was erroneously excluded from the service list, the party to be served, in the
10 absence of extraordinary circumstances, will be entitled to an order extending the date
11 for any response or the period within which any right, duty or other act must be
12 performed.

13 VI. CONVENTIONAL FILING OF DOCUMENTS

14 Parties otherwise subject to an electronic filing order may be excused from filing a
15 particular document electronically if it is not available in electronic format and it is not
16 feasible for the filer to convert it to electronic format by scanning it to PDF. Such a
17 document may be manually filed with the Clerk of Court and served upon the parties in
18 accordance with the applicable provisions of the Code of Civil Procedure and the Rules
19 of Court for filing and service of non-electronic documents. Parties manually filing a
20 document must file electronically a Notice of Manual Filing setting forth the reason(s)
21 why the component cannot be filed electronically.

22 A. DOCUMENTS FILED UNDER SEAL

23 A motion to file documents under seal must be filed and served electronically.
24 However, documents lodged with the court conditionally under seal, as provided in
25 Rule of Court 243.2(d), must be submitted in paper form, pending hearing on a motion
26 to seal.

27 B. EXHIBITS AND REAL OBJECTS

1 Exhibits to declarations that are real objects, i.e., construction materials, core samples,
2 etc. or other documents, i.e., plans, manuals, etc. which otherwise cannot be
3 comprehensively viewed in an electronic format must be filed and served
4 conventionally, in paper form.

5 C. LODGMENTS

6 Documents attached to a Notice of Lodgment must be lodged and served conventionally
7 in paper form. However, the actual document entitled "Notice of Lodgment" must be
8 filed electronically.

9
10 VII. **COLLECTION OF FEES**

11 A. COURT FEES

12 Statutory filing fees must be paid to Glotrans for electronic transfer to the Santa Clara
13 Superior Court's bank account system. Parties must pay said filing fees to Glotrans by
14 credit card at the time of the electronic filing of documents.

15 B. VENDOR FEES

16 Fees charged by Vendor to parties or attorneys for access to and electronic
17 transmission of documents are solely the property of Vendor and are in addition to any
18 charges associated with statutory filing fees of the Superior Court.

19 VIII. **SERVICE OF ELECTRONIC FILING ORDER ON NEW PARTIES**

20 Any litigant filing a complaint or adding a party to a case by filing of an amended
21 complaint, cross-complaint, complaint in intervention, interpleader or other initiating
22 document must serve this Electronic Filing Order at the same time the pleading is
23 served.

24 IX. **ELECTRONIC FILING AND SERVICE OF ORDERS AND OTHER PAPERS**

25 The Court will issue, file, and serve notices, orders, and other documents
26 electronically, subject to the provisions of this Order. No paper service will be made
27 by the court.

28 X. **PUBLIC ACCESS AND PRIVACY**

1 A. PERSONAL IDENTIFIERS

2 Except as provided in Rules of Court 2070 through 2076, an electronically filed
3 document is a public document at the time it is filed unless it is sealed under rule
4 243.2(b) or made confidential by law. [See Rule of Court 2054(d)]. In order to promote
5 electronic access to case files while also protecting personal privacy and other
6 legitimate interests, parties must refrain from including, or must redact where inclusion
7 is necessary, the following personal data identifiers from all pleadings and other papers
8 filed with the court, including exhibits thereto, whether filed electronically or in paper,
9 unless otherwise ordered by the court.

10 (a) **Social Security numbers.** If an individual's social security number
11 must be included in a pleading or other paper, only the last four digits
12 of that number may be used.

13 (b) **Names of minor children.** If the involvement of a minor child must
14 be mentioned, only the initials of that child may be used.

15 (c) **Dates of birth.** If an individual's date of birth must be included in a
16 pleading or other paper, only the year may be used.

17 (d) **Financial account numbers.** If financial account numbers are
18 relevant, only the last four digits of these numbers may be used.
19

20 B: PRIVILEGED OR CONFIDENTIAL INFORMATION

21 No party may intentionally include within pleadings, nor attach as exhibits, any other
22 matter that the party knows to be properly subject to a claim of privilege or
23 confidentiality.

24 C. FILING OF SENSITIVE DOCUMENTS

25 A party wishing to file a document containing the personal data identifiers listed above,
26 or material known to be subject to a claim of privilege, must file an unredacted
27 document under seal as provided herein. The party must file a redacted copy for the
28 public file.

1 D. RESPONSIBILITY FOR REDACTION

2 The responsibility for redacting personal identifiers and privileged or confidential
3 information rests solely with counsel and the parties. The Clerk will not review each
4 pleading or other paper for compliance. The court may impose sanctions for violation
5 of these requirements.

6 **XI. SIGNATURES [RULE OF COURT 2057]**

7 A. DOCUMENTS UNDER PENALTY OF PERJURY

8 When a document to be filed electronically requires a signature under penalty of
9 perjury, the document is deemed signed by the declarant if, before filing, the declarant
10 has signed a printed form of the document. By electronically filing the document, the
11 electronic filer indicates that he or she has complied with this requirement and that the
12 original, signed document is available for review and copying at the request of the
13 court or any part. At any time after the document is filed, any other party may serve a
14 demand for production of the original signed document.

15 B. DOCUMENTS NOT UNDER PENALTY OF PERJURY

16 If a document does not require a signature under penalty of perjury, the document is
17 deemed signed by the party submitting it if the document is filed electronically.

18 C. DOCUMENTS REQUIRING SIGNATURES OF OPPOSING PARTIES

19 When a document to be filed electronically, such as a stipulation, requires the signature
20 of opposing parties, the following procedure applies: (1) The party filing the document
21 must obtain the signatures of all parties on a printed form of the document; (2) The
22 party filing the document must maintain the original, signed document and must make
23 it available for review and copying; (3) By electronically filing the document, the
24 electronic filer indicates that all parties have signed the document and that the filer has
25 the signed original in his or her possession.

The matter was called and heard. The Court advised all counsel present that future hearings may be held in the Los Angeles County Superior Court.

The Court ordered that Electronic Filing and Service be mandatory for this matter. As to the (1) Stipulation & Proposed Order re Electronic Filing and Service, and (2) Electronic Filing and Service Order, the Court ordered all parties to review these two documents, if they have not already done so, and to submit any specific modifications or requests to the Court as soon as possible or otherwise sign the stipulation as an acknowledgement of the rules, processes and procedures to be followed with regard to electronic filing. For all parties that have already been served with the complaint(s), responsive pleadings are due within 30 days (by October 27, 2005); the hearing date on any demurrers will be coordinated by the Complex Civil Litigation Coordinator.

A Further Case Management Conference was set for **Friday, December 2, 2005 at 10:00 a.m., location to be determined**; the Court will provide notice by mail.

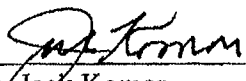
