$1 \parallel I.$ INTRODUCTION

Plaintiff Richard Wood has reached agreement on the terms of a partial settlement
agreement of the Small Pumper class action with counsel for California Water Service
Company, City of Lancaster, Palmdale Water District, Phelan Piñon Hills Community
Services District, Quartz Hill Water District, and Rosamond Community Services
District. That agreement will be filed later today along with the Motion for Preliminary
Approval of Partial Class Settlement.

⁸ Counsel for the parties to the settlement believe that it comports with the Court's
 ⁹ comments at the preliminary approval hearing on the 2011 settlement of the Small
 ¹⁰ Pumper class action. Class counsel believes the agreement is in the best interest of the
 ¹¹ class, and will likely reduce the scope of future trials.

III. REQUESTED RELIEF

14 Counsel have worked for several months and have reached the terms of a partial 15 settlement that would resolve all claims among and between the class and six of the 16 named defendants. The terms of the settlement, which include among other terms, the 17 resolution of prescription claims, require final approval of this settlement well before the 18 current Phase 6 trial date. Given that it will take many months for the full settlement 19 approval process to occur, including notice to the class and a fairness hearing, and the 20 Court's unavailability from October 26 to November 18, as well as conflicts among 21 counsel's schedule and the Thanksgiving Holiday, the hearing on the motion for 22 preliminary approval likely could not be heard until December.

Therefore, the parties wish to hold the hearing on the preliminary approval of the settlement on Friday, October 25, 2013, and request an order shortening time that would set a briefing schedule allowing opposing parties a full statutory time period to file opposing papers. Plaintiff proposes that opposition papers be filed October 21 with no reply papers. Alternatively, at the Court's discretion, the opposition filing date could be
