- 6 1. *Leisure Lake Mobile Estates*. This mobile home park is owned by two
7 entities, Goodyork Corporation and Lancaster Summit Properties, Ltd.
8 It is located within the area of adjudication at 48303 North 20th Street
9 West, Lancaster, California 93534 (APN 3116-015-002 & 3116-015-
10 002). The property owner informally reports producing approximately
11 130 acre feet of groundwater per year.
- 12 2. *Robar Enterprises, Inc.* This entity owns parcel number 3050-008-
13 030, which is also located within the area of adjudication. The owner
14 reports using approximately 650 acre-feet per year for the purpose of
15 building material supply (ready mix concrete, sand and gravel).
