DECLARATION OF BRADLEY T. WEEKS

Quartz Hill Water District applies for an order requiring the parties set forth on Exhibit Five to the Declaration of Bradley T. Weeks to show cause why their water right claims, or in the alternative, all claims based upon historical groundwater pumping, should not be lost.

This application is made pursuant to the provisions of Code of Civil Procedure section 1211 on the grounds that on November 16, 2011 this court issued an Order to Show Cause to the parties of this case to provide the following information:

- 1. The amount of the water right, if any, you are claiming in this lawsuit;
- 2. The amount of pumping, if any, you are claiming in this lawsuit;
- 3. The location and source of such pumping;
- 4. The basis for the computation of claimed pumping, such as metering; and
- 5. The time frame for the pumping from which the calculations were made.

The parties listed on Exhibit Five to the Declaration of Bradley T. Weeks failed to provide the required information or show cause why their water rights should not be lost. This application is based upon the accompanying declaration of Bradley T. Weeks and the records and files in this action.

DECLARATION OF BRADLEY T. WEEKS

I, Bradley T. Weeks, declare as follows:

- I am the attorney for Quartz Hill Water District, a party in this action. 1.
- 2. On November 16, 2011, this court posted the Order to Show Cause ("OSC") attached to this declaration as Exhibit One.
- 3. The OSC required that the listed information be filed with the court at the Superior Court Clerk's office, Los Angeles Superior Court, Central-District-Central Civil West Courthouse, 600 S. Commonwealth, Room 314, Los Angeles, or posted electronically to the case website no later than December 6, 2011.
- 4. The parties were advised in the OSC that "Failure to file and post this information to the case website may result in a loss of your water rights."
- 5. The OSC was directed to all parties to this litigation, excepting those parties listed on Exhibit A to the OSC.
- I prepared Exhibit Two to this declaration. I have reviewed the E-Service List for 6. this case and E-Service list for the electronic service OSC. Exhibit Two is a list of all parties who have registered for electronic service in this case and received electronic service of the OSC¹. Exhibit Two does not include the parties listed on Exhibit A to the OSC.
- 7. The OSC was posted on the Santa Clara Superior Court website on November 16, 2011.
- 8. I thereafter compiled a list of the parties who had answered and had not registered for electronic service. This list is attached to this declaration as Exhibit Three. Most of these answers were electronically filed by the County of Los Angeles between December 20, 2006 and December 29, 2006, items 398 thru 406 on the court's website. I mailed a copy of the OSC to these parties at the addresses listed on their answers on November 23, 2011. I posted the proof of service of this mailing on November 23, 2011.

Since service of the OSC three parties have registered for electronic service: Baxter Mutual Water Co.; Chavez, Efren; Qarmout, Elias. All three of these parties responded to the OSC.

- 9. In summary, Exhibit Two to this Declaration is a list of all parties who have electronically registered for service and were obligated to respond to the OSC. Exhibit Three is a list of parties who filed answers in this action and who had not registered for electronic service.
- 10. Exhibit Four to this declaration is a list of all the parties who did respond to the OSC and whose responses have been posted on the Santa Clara Superior Court website. I understand that some parties filed paper responses with the Los Angeles Superior Court. I do not have a copy of those filings, and I don't know who those parties are, but I will supplement this declaration once I have that information.
- 11. Exhibit Five is a list of those parties who should have responded to this court's OSC but who have failed to do so. I created this list by combining the parties who registered and did not register for electronic service (Exhibits Two and Three), and subtracted those parties who posted a response (Exhibit Four).
- 12. As the court may recall, the only party to appear at the OSC on December 13, 2011, did not provide any documents, and stated his client had not historically pumped groundwater.
- I request this court issued the proposed order that accompanies this declaration. I 13. will serve it by mail on those parties who have not registered for electronic service.
