**ORDER TO SHOW CAUSE RE IMPOSITION
OF SANCTIONS FOR FAILURE TO
PROVIDE INFORMATION TO COURT**

Quartz Hill Water District, having presented to this Court sufficient grounds to initiate a
contempt proceeding and good cause appearing therefore, all parties listed on Exhibit One are
ordered to appear on February 14, 2012, at 9:00 a.m., or as soon thereafter as this matter may be
heard at the Los Angeles Superior Court, Central Civil West, 600 South Commonwealth Avenue,

1 15th Floor, Room 1515, Los Angeles, California, 90005 to show cause why the imposition of
2 sanctions resulting in the loss of your water rights or loss all water right claims based upon
3 historical groundwater pumping, should not be imposed.
