The Public Water Suppliers listed above have reviewed the parties' declarations in lieu of deposition testimony submitted pursuant to this court's amended Case Management Order dated January 16, 2013. As a result, the number of depositions now scheduled is less than half the number of depositions that were scheduled before the last Case Management Conference on January 16, 2013. Scheduled depositions have been reduced from 135 to 66 with many of the remaining depositions for parties' designated expert witnesses. Additionally, the depositions are expected to be of shorter duration.

The Public Water Suppliers listed above anticipate they can stipulate to certain declarations in lieu of testimony after analysis and discussion are completed. We respectfully suggest that the Court consider extending the February 28, 2013 deadline to the next scheduled Case Management Conference, March 25, 2013.

At this time, there are certain declarations for which there can be no stipulation because of incomplete, inaccurate or otherwise disputed information.

Finally, some parties may claim that the filing of a declaration, even absent a stipulation, will foreclose other parties' opportunity to take that party's deposition or that the declaration constitutes facts established during trial.
